You have the right to revoke this consent at any time by providing a written statement to us, including via email. If we have already shared your information with others to assist you, it may be more challenging for us or them to do so if you withdraw your consent.

We will provide you with a link to our privacy statement, which outlines how we protect and may share your information. If you are unable to access our privacy statement via the link provided, we will furnish you with a copy upon request.

Research Use and Disclosure Policy

1. Purpose

The purpose of this Research Use and Disclosure Policy is to outline guidelines for the collection, use, and disclosure of information gathered by St Vincent de Paul – Phoenix. This policy aims to ensure the ethical and responsible handling of data while promoting transparency and compliance with relevant regulations.

2. Scope

This policy applies to all employees, volunteers, contractors, partners and guests/patients of St Vincent de Paul- Phoenix.

3. Definitions

- **Research**: Systematic investigation designed to develop or contribute to generalizable knowledge.
- Data: Any information collected, stored, or processed for research purposes.
- Use: The utilization of data collected by St Vincent de Paul-Phoenix.
- Disclosure: The sharing or dissemination of data with external entities.
- **Participant Consent**: Permission obtained from individuals to use their data for research purposes.

4. Data Collection

- St Vincent de Paul- Phoenix collects data for research purposes with the consent of participants. Consent procedures are conducted in accordance with ethical standards.
- Data collection methods prioritize the protection of participant privacy and confidentiality.
- Data collected must be relevant to the research objectives and limited to what is necessary for the intended analysis.

5. Use of Research Data

- Research data collected by St Vincent de Paul-Phoenix may be used for various purposes, including program evaluation, needs assessment, and outcome measurement.
- Data use is restricted to authorized personnel involved in services, program administration/oversight/reporting and research activities.

6. Disclosure of Research Data

- Research data may be disclosed to external entities for collaborative research projects, evaluation purposes, or to fulfill legal or regulatory obligations.
- Prior to disclosing research data, St Vincent de Paul- Phoenix ensures that appropriate data sharing agreements are in place to protect participant privacy and confidentiality.

• Disclosure of data to third parties is done in accordance with participant consent.

7. Data Security and Confidentiality

- St Vincent de Paul-Phoenix implements measures to safeguard the security and confidentiality of data, including access controls, and secure storage systems.
- Access to data is restricted to authorized personnel with a legitimate need for access to perform their duties.

8. Compliance and Oversight

- Compliance with this policy is mandatory for all individuals involved in data activities at St Vincent de Paul-Phoenix.
- The Data Governance Committee (DGC) oversees the implementation of this policy and ensures adherence to ethical standards and regulatory requirements.
- Any concerns or violations of this policy should be reported to the DGC for investigation and resolution.

9. Policy Review

- This policy shall be reviewed periodically to ensure its effectiveness and relevance to St Vincent de Paul's data activities.
- Amendments to this policy may be made as necessary to reflect changes in laws, regulations, or organizational procedures.
