

Release and Waiver of Liability Form

This Release and Waiver of Liability (the "release") executed by ("Volunteer") releases St. Vincent de Paul (also referred as SVdP) a nonprofit corporation organized and existing under the laws of the State of Arizona and each of its directors, officers, employees, and agents. The Volunteer desires to provide volunteer services for SVdP and engage in activities related to serving as a volunteer.

Volunteer understands that the scope of Volunteer's relationship with SVdP is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer; SVdP will not provide any benefits traditionally associated with employment to Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Volunteer's service to SVdP.

1. Waiver and Release: I, release and forever discharge and hold harmless SVdP and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to SVdP. I understand and acknowledge that this Release discharges St. Vincent de Paul from all liability or claim that I may have against SVdP with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to SVdP or occurring while I am providing volunteer services.

2. Insurance: Further I understand that St. Vincent de Paul does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of SVdP.

3. Medical Treatment: I hereby Release and forever discharge St. Vincent de Paul from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with SVdP.

4. Assumption of Risk: I understand that the services I provide to St. Vincent de Paul may include activities that may be hazardous to me including, but not limited to driving, lifting, pushing, pulling, use of cleaning chemicals, etc. involving inherently dangerous activities. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and Release SVdP from all liability.

5. Photographic Release: I grant and convey to St. Vincent de Paul all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by SVdP in connection with my providing volunteer services to SVdP.

6. Other: As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Arizona and that this Release shall be governed by and interpreted in accordance with the laws of the State of Arizona. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
